

Pant National Institute of Himalayan Environment (GBP-NIHE), Almora–263 643, Uttarakhand has decided to sign a Letter of Agreement (LoA) with Mizoram University, Aizawl to implement NMHS funded 'Himalayan Knowledge Network- HKN project (2021-2022)' activities in Mizoram in collaboration with Mizoram University, Aizawl.

A total grants of Rs. 5,00,000/- (Rupees Five Lakh only) is approved for this assignment that will be released in two installment by GBPNIHE, Kosi-Katarmal, Almora for establishing 'HKN State Chapter' for State of Mizoram at Mizoram University, Aizawl and conducting the project activities (as detailed above).
